



Last night an unhoused man broke into my home at 1126 10th Ave SE. I don't know his full story, but I have reason to belive my house was targeted due to the proximity to the bus stop for route 64. We have lived at this house for two years, and I was initially pleased to have a bus stop so close because I am a fan of a robust public transportation network and a long time bus rider. Unfortunately, the vast majority of the people I observe using this stop get off and walk west to eastside, and the location of this stop is not really serving the direct neighborhood community. I have long felt like the location of this stop set is purely as a layover location for busses to idle when they're running early. There is a stop just a block further up the road, and a stop right around the corner on eastside. This stop isn't necessary. It's a mite closer to the tiny home community tucked next to the city maintenance yard than the one on eastside, so it is constantly in use from folks visiting their friends there. I have two asks. One, I'd like to discuss what steps we can take to review the necessity for this stop at all. I've seen a lot of investment going into this location, so I know it's a big ask. I've long wished to suggest it, but assumed I'd get shut down since there's a shelter here. However, one feels a bit bolder when a strange man breaks into their home. We've had items stolen from our back yard. We've installed a fence and security cameras. But to have THIS many eyes off specifically desperate people on our house every day, I now feel like this was bound to happen. This is unsafe, the bus stop that these folks use needs to be located next to where they need to go. My second ask is to evaluate the suitability of this location as a layover spot. It is impossible to use our yard and have a fluid conversation- the busses idle there so long and so often. It's very loud. When the news folks came by to interview me about the home invasion, we had to go inside because the busses were so loud. I can't leave my front door open on sunny days because then our living room sounds like a grumbling diesel engine 10 minutes out of every 30. At the very least, I would like drivers to immediately stop idling engines if they must stop here for prolonged periods. Turning the engine off is better for the environment, and for goodness sake this is a residential neighborhood I'm surprised I even have to ask this. I want to emphasize that I am an advocate for public transportation and I appreciate all that you do. I am not making these requests lightly, and I hope you give genuine thought to how we can work together to make sure the whole community can get the best service.




